### **Rules & Information**

- Ages 7-12 years old must grill a burger.
- Contestant must meet age requirement at time of contest on October 12, 2019.
- Meat will be provided to each contestant. Contestants are responsible for shaping and seasoning meat.
- Each contestant is required to have at least one adult present at all times. Adults will tend the heat source, handle knives and check meat for doneness only.
- Adults may not help shape, season, grill or garnish the burger.
- Contestants are required to provide lighting agent, matches/lighter, utensils, seasoning/marinade, water and garnish if desired. It is the responsibility of the adult to maintain a clean and safe environment.
- Entry fee is \$25 per contestant. Parent/Guardian must complete entry form.
- There is a strict limit of 30 contestants; registration is due by September 27, 2019.  
Space is given on a first-come, first-served basis.
- Grills may be taken home by the contestant at the end of the contest, after properly disposing of coals.
- Check-In 8:30am, Start Grilling 9:00am, Burgers Due 10:15am, Awards 12:30pm.
