- Check-In Times: Friday, October 11th 6pm-8pm OR Saturday, October, 12th 5am-7am
- All contestants must attend a mandatory meeting Saturday, October 12th at 7:30am
- Meat must be cooked on site; wood, charcoal or wood pellets are acceptable (See KCBS rules for details)
- Two categories: Ribs and Chicken (contestants must participate in both categories)
- Entries will be judged on appearance, taste, and texture (KCBS Cooking & Judging Rules apply)
- Contestant must provide meat, power, water and any necessary supplies and equipment
- If using a generator, please understand that the generator must be 70dB or less
- If a contestant wishes to be a vendor, a vendor application must be received with payment in addition to the contestant registration form. No contestant shall vend food or merchandise unless authorized.
- Judging begins at 4pm (Chicken due at 4pm, Ribs due at 4:30pm), Awards announced at 6:30pm
- Trophies awarded to Grand Champion, Reserve Grand, and 1st/2nd/3rd place finishers in each category
- Prize money: Grand Champion (\$500), Reserve Grand (\$300), Payout to top five winners of each category as follows: 1st (\$200), 2nd (\$150), 3rd (\$100), 4th (\$75), 5th (\$50).
